The above table clearly shows EDI failure is the major problem faced by the customs clear agent followed by the cost of service is high. Labour problems secured the third position followed by inadequate space in the warehouse. Customs problems secured the fifth position followed by no heavy handling equipment, safety and security problem faced by the cargo, lack of availability in track, service failure, and delay of shipment and assessment are remaining problems.

# **Findings of Summary**

Regarding the problems faced by the customs house agents point out that out of 150 respondents majority of 92 percentage of them faced the problem of inadequate size of packages of the goods. In this case of problems faced by the respondents during custom clearance shows that a maximum of 90.67 percentage of the respondents faced the problem of over valuation of stocks. Regarding the problems faced by the respondents when dealing with ICD/CONCOR observed that EDI failure is the biggest problem faced by the respondents followed by the high cost of service and labor problem respectively in Chennai Port Trust.

# **Suggestions**

To carry out the problems faced by the customs house agents, the following remedies are recommended.

It is understood from the analysis that the inadequate size of the package is the biggest problem confronted by the respondents. Over valuation of stock, followed by the EDI failure, cost of service is high and also dealing with ICD/CONCOR. To solve these above problems, it is suggested that the obtainable price preference offered by the Government should be properly implemented. Strict rules and regulations are implemented first its avoid unnecessary customs agents entering the market. Wages revises also help to solve the solution of the labour problems.

# Conclusion

This study concluded from the above findings

that the number of registered customs house agents' employment generation, the total investment made, and export and import have increased every year in the Chennai harbor. So the Government restricts the rules and regulations of customs agent houses. The most common problems faced are custom house agents were the inadequate size of a package of goods in the container, over valuation of stock, and EDI failure found in the study. The Government sector arranges different adequate services for the container and also arranges proper EDI facilities.
