Eco Healing Escapes and Sustainable Tourism Evolution

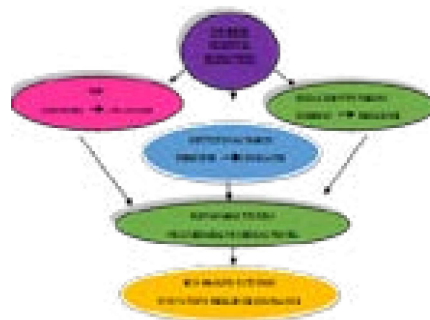
